


Our Goal:

The goal of Children's Safe Harbor is to reduce the trauma of child victims and their non-offending caregivers by facilitating a comprehensive, multi-disciplinary team approach to intervention, investigation, prosecution and treatment of child sexual and severe physical abuse.



Highlights: 20 Years

Forensic Interviews (1998-2018)



From the beginning, Children Safe Harbor's principle mission has been to provide a supportive, safe environment for children while enhancing the coordination between criminal investigations and the monitoring of child abuse cases. Instead of children unnecessarily accessing multiple law enforcement agencies and child protection systems to seek healing and justice, Children's Safe Harbor utilizes a multi-disciplinary, team-oriented approach to successfully coordinate effective, efficient, and child-centered casework. This method allows Children's Safe Harbor to offer victimized children the care they need while also ensuring that the evidence necessary for prosecution is gathered effectively and that mental health resources for the children and non-offending family members are coordinated through completion of care.

In its first few months, approximately 23 children were referred to the organization for a forensic interview. Now, the average number of forensic interviews is close to 200 a month. In 2017, Children's Safe Harbor was designated as a High Capacity children's advocacy center in the state of Texas. We were ranked 7th out of 71 active centers.

Counseling Successes

4,481 hours of counseling services were provided to clients, free of charge. Of the clients in counseling, 92 were discharged having successfully completed the TF-CBT recommended 12 sessions of treatment. After just 6 sessions, 92% of caregivers reported that they had noticed positive changes in their child. "I instantly felt comfortable and safe in a foreign situation. I really appreciate how comforting and helpful the staff was. The facility was very clean and inviting."

Volunteers

In 2018, we had 65 volunteers providing direct service work for a

total of 2,600 hours. In addition, CSH received help from various special groups. The "Dolly Mamas" generously donated beautiful, handmade dolls for our clients. Exxon Mobil supported CSH with their annual Day of Caring, by sending 50 employees to help with various facility projects, including painting, landscaping, construction & safety.

Education & Awareness

CSH Staff provided 28 specialized prevention and awareness programs in 2018. Through various programs, including Darkness to Light (D2L), and Netsmartz, 640 individuals around the community received education and awareness.

Special Group Spotlight: BACA


The 43 members of the Seven Coves Chapter of Bikers Against Child Abuse (BACA), work alongside CSH in creating a safer environment for abused children. They exist as a body of Bikers to empower children to not feel afraid of the world in which they live, by supporting each child based on their individual needs. Some of these services may include: having a physical presence at the child's home, therapy needs, visiting at school, and accompanying children to court. In addition to all else BACA does, they hosted our annual client Christmas Party, with a bounce house, great food, presents, a ton of fun, and even Biker Santa!



Forensic Interviews are typically the first service provided for our families. A forensic interview is a neutral, fact finding interview conducted by someone who is specifically trained according to Texas standards.

Multidisciplinary Team (MDT)

Children's Safe Harbor, as a children's advocacy center, has two sets of customers: MDT partners (LE, DFPS) and the children and families that they bring as part of a criminal investigation of child abuse. The MDT is the core feature of this model of healing and justice.

5,611 Statewide Intake Reports

Specialized staff of CSH reviewed these 5,611 DFPS intake reports for local law enforcement in Montgomery County. 
