JUSTICE

The Children's Advocacy Center movement began from the vision of a child abuse prosecutor in Huntsville, Alabama. The intent to not re-victimize children from having to retell their story in an ongoing investigation, has remained central to our mission nationwide for over 30 years.

For over 25 years Children's Safe Harbor staff have worked alongside dedicated law enforcement and prosecution teams from Montgomery, Walker and San Jacinto Counties to sanction child predators.

In the past five years, the detectives assigned to The Montgomery County Sheriff's Office Special Victims Unit (SVU) have reviewed over 16,000 Child Protective Service reports and investigated over 1,300 of the most heinous crimes imaginable. In that time, these men and women have arrested and charged over 400 child predators with these defendants receiving over 2,500 combined years in prison.

April 2023 Impact

April marks National Child Abuse Prevention and Awareness Month. April 2023 Children's Safe Harbor made an impact across the community during April 2023 from meeting with hundreds of students at Sam Houston State University to speak about our services and the signs and symptoms of child abuse, setting up pinshweels in church lawns, and our annual pinwheel display. Children's Safe Harbor's annual pinwheel display for 2023 took place in front of Montgomery County Constable Precinct 3 Ryan Gable, where 2,303 pinwheels were displayed in honor of all the children that walked through our doors in 2022.

Here is how your continued support impacts the lives of children for the better...

In 2023, the San Jacinto County District Attorney's office handled multiple cases involving the sexual assault of children. One case resulted in a life sentence, while the other cases totaled 95 years.

Jesus "Jesse" Rodriguez was found guilty of Continuious Sexual Abuse of Young Children of 2 young girls on Thursday, March 2, 2023 and received 30 years in prison. The jury heard testimony from multiple witnesses including the CSH forensic interviewer and counselor.

On March 20, 2023 Gary Russell Motter of San Jacinto County was found guilty on two counts of Aggravated Sexual Assault of a Child younger than 14 years of age and sentenced to 40 years in prison. Jurors heard testimony from deputies from the San Jacinto County Sheriff's Office, counselors and the Children's Safe Harbor forensic interviewer. During the punishment phase of the trial, jurors heard testimony from another victim of rape out of Arkansas. Following the trial, District Attorney Todd Dillon thanked the multiple agencies including Children's Safe Harbor for their hard work, care and persistence in the case. "This sentence is a clear message to anyone who would prey on children in San Jacinto County. We will protect our children by holding you accountable," said Dillon. "Children should be able to rely on their parents and stepparents, not be violated by them."

On November 2, 2023, Steven Clary was found guilty of Sexual Assault of a Child and received life in prison. The sexual assault occurred in Shepherd, Texas. The initial outcry was made by two young boys related to Clary. Detective Sheik recovered images on the defendant's phone that corroborated the children's statements. The sexual assaults occurred after Clary was released from prison after serving time for Indecency with a Child.
