Through your belief in our unique counseling program,
we know children are **HEALED** from **ABUSE & TRAUMA**.



At Children's Safe Harbor, all of our counseling services are
at **no cost**. Our compassionate and highly trained
counselors specialize in

Trauma-Focused Cognitive Behavioral Therapy (TF-CBT)

to support children on their path to healing. Through a
variety of therapeutic techniques, we help children
process and overcome traumatic experiences in a safe,



nurturing environment. **Our approach is effective—**
after just 12 sessions, **over half** of the children
no longer show signs of **post-traumatic stress**, and **71%**
experience relief from depression symptoms. We are
dedicated to helping every child feel safe and supported.
